A message from Cathy Ulrich, Chief Executive Officer (CEO), and Dr. Charles Jago, Board Chair

2013-2014 was an exciting year for Northern Health. Integrated Health Services, the way we are delivering coordinated health care services, took significant steps forward. Integrated Health Services features different health care providers working together with the patient at the centre. We hope it will lead to increased quality of care and better health outcomes for Northerners.



In March 2014, two multidisciplinary teams started an Integrated Health Services prototype at the Highland Health and Family Development Centre in Prince George.

The teams, which are closely linked to various family doctors' practices, coordinate care for patients including the frail elderly, people living with addiction or mental health issues, pregnant women and new mothers, and people with multiple chronic conditions such as diabetes, high blood pressure, and heart disease.

The knowledge we gain from this experience will help us develop a transition plan for the rest of Prince George, with the goal of achieving better integrated, more accessible health services by October 2015.

Similar Integrated Health Services prototypes are also under way in Fort St. John and Fraser Lake.

At Northern Health, we are continuously striving to implement best practices based on current research. Accreditation is one tool we use to do this: every four years, we host visits from Accreditation Canada, which works with health care organizations to help them improve quality, safety, and efficiency. In previous accreditation reviews, Northern Health has consistently met national standards of excellence.

To prepare for our June 2014 accreditation, more than 1500 Northern Health staff and physicians completed self-assessment surveys. As well, different Required Organizational Practices (ROPs) were profiled to staff and physicians each week, such as educating patients about safety.

We have full confidence that Northern Health will continue to meet Accreditation Canada's benchmark standards of excellence.

Another highlight of 2013 was the community consultation series, "Let's Talk about Healthy Aging and Seniors' Wellness," which focused on the health and well-being of Northern seniors. Consultations were held in 13 communities, and focus groups were held in some communities as well. The consultation was attended by people of all ages, and all participants' ideas were captured and recorded to form a report now available on www.northernhealth.ca. The findings from this consultation will inform Northern Health's approach to providing services to this important and growing part of the population we serve.

We would like to thank everyone who took the time to attend these consultations, as well as everyone who was not able to attend, but still took the time to share their opinions with us.

We wish all of you a happy and healthy 2014-2015.

 New observation room for mental health department; emergency department was redesigned to support the functions of this new room (\$0.8 million)



- Building automation system software upgraded, which controls heating, ventilation, and air conditioning (HVAC) (\$0.2 million)
- Renovation to existing laboratory to address issues with space, technological advances, storage, workflow and patient confidentiality (\$0.9 million)
- Replacement of 40-year-old waste system drain lines (0.6 million)

2013-2014 projects in your region: **Northern Interior**

Burns Lake: Lakes District Hospital and Health Centre

 New hospital and health centre project (\$55 million)

Mackenzie: Mackenzie and District Hospital and Health Centre

 Boilers replaced with two new fuel-efficient models (\$0.4 million)

Prince George: University Hospital of Northern British Columbia

- Construction of a new six-bed highly sophisticated intensive care unit, known as the "high acuity unit" (\$4.6 million)
- New Learning & Development Commons area which will provide a state of the art teaching and learning centre for medical students and health care professionals (\$9.9 million)
- High-voltage distribution transformers replaced; these provide power to all of the hospital's essential circuits (\$0.1 million)

Quesnel: Dunrovin Park Lodge

- Purchase and installation of a real-time location and communication system, which helps staff quickly find residents for various care needs (\$0.2 million)
- Proximity card access installed on all critical entry/exit doors around the lodge (\$0.2 million)

Quesnel: GR Baker Memorial Hospital

- Pharmacy space increased to enhance security, provide more workstation space for staff, meet College of Pharmacists of BC standards, and ensure sterile products preparation (\$1.8 million)
- Replacement of two patient elevators (\$0.7 million)
- Upgrade to medical air system, including pumps, vacuum, controls and alarms to meet new code requirements (\$0.3 million)

Vanderhoof: St. John Hospital

 Emergency department renovations, including improvements to patient flow to and from the ambulance, ventilation and fire protection, removal of hazardous materials and enlarging reception, admitting and waiting areas, as well as increased privacy for emergency patients (\$5 million)

Dawson Creek: Dawson Creek and District Hospital

- Replacement of nurse call system (\$0.4 million)

- Maternity wing renovations with new services and equipment (\$0.6 million)

Financial Summary

Northern Health provides a wide range of health services to the population it serves. Each year, Northern Health is challenged to provide high-quality accessible services within the available financial, human, and capital resources. For the fiscal year ended March 31, 2014, Northern Health realized an operating surplus of \$13.8 million (1.9% of revenues).

The largest contributor to the past year's operating surplus was the actuarial gain on long-term disability benefits. The Healthcare Benefits Trust (HBT) administers the long-term disability benefits plan for all BC health authorities. Annually, HBT performs an actuarial valuation of future claims, payments to beneficiaries, and expected return on the plan's assets. Any change in the valuation from one year to the next is recorded as a current year gain or loss. For the fiscal year ended March 31, 2014, as a result of improved management of long-term disability claims and better than expected investment returns, the trust experienced an actuarial gain that was recognized in the past year. Northern Health's share of this gain was \$11.3 million.


If Northern Health had not experienced this actuarial gain, then the annual operating surplus would have been \$2.5 million (0.3% of revenues).

Revenues

Total revenues for the year were \$745.5 million; an increase of \$11.7 million or 1.6% from the prior year. Funding from the Ministry of Health is Northern Health's primary source of revenue. In 2013-14, operating funding from the Ministry of Health was \$541.7 million, which represented 73% of total revenues.

Expenses

Total expenses for the year were \$731.7.0 million; an increase of \$6.7 million or 0.9% from the prior year. Acute care remains the largest sector of expenditure at \$434.8 million or 60% of total expenses. The next largest sector is residential care at \$97.4 million or 13% of total expenses. 


The goals of the consultation were to:
