## Reminder: People need the BC Vaccine Card to access certain settings

The BC Vaccine Card is now the only acceptable proof of vaccination for British Columbians to enjoy certain businesses and recreational events safely.

## Clarification: There is no shortage of injectable naloxone for Take Home Naloxone Kits

In a recent media coverage the premier announced that there was a provincial shortage of naloxone. This communication was referring to intranasal naloxone for police and RCMP

members. There currently is **no shortage of injectable naloxone** for the Take Home Naloxone program.

BCCDC continues to closely monitor their naloxone inventory, and currently have no supply issues. There may be delays in shipping due to increases in weekly order volume, but BCCDC will communicate any delays with distribution sites if the come up. BCCDC will also monitor for any urgent Naloxone requests and if a site is urgently needing any supplies they can contact <a href="mailto:naloxone@bccdc.ca">naloxone@bccdc.ca</a>

## Preferred proponent chosen for new Dawson Creek hospital

People in Dawson Creek and area are one step closer to a new hospital now that a preferred proponent has been selected for the design phase.

"The selection of the team that will design the new hospital means another important milestone has been reached for people in the region," said Adrian Dix, Minister of Health. "The new and bigger facility will deliver public health-care services to people in the South Peace for decades to come."

As a result of the evaluation process, in co-ordination with Northern Health and Infrastructure BC, Clark Builders-Turner-HDR Architecture was selected.
