# National Immunization Awareness Week

April 26<sup>th</sup>-May 3<sup>rd</sup> was National Immunization Awareness Week. This coincides with World Immunization Week in the Americas. There are many new innovative ideas to help promote Immunizations and help people keep track of their families' immunizations. These include the Booster campaign, new immunization 'App', and Text Messaging Service. Each of these exciting ideas is discussed throughout this newsletter.

There is also a variety of different resources available from the <u>immunize.ca</u> website to promote National Immunization Awareness Week. They offer a variety of great ideas that communities can use to promote this week. Some of them include Immunize Canada colouring books, immunization quizzes, and posters available for print.

# World Immunization Week

World Immunization Week was April 24-30, 2014, with the aim of promoting one of the world's most powerful tools for health - the use of vaccines to protect people of all ages against disease. The theme for 2014 is "Are you-up-todate?" Immunization is widely recognized as one of the most successful and cost-effective health interventions ever introduced, and it prevents between 2 and 3 million deaths every year. ### New "App" to help Canadians keep track of their immunizations

Immunize Canada has just released a free online immunization record app that includes immunization schedules for all provinces and territories. Downloading this app will allow people to keep an active record of their immunizations for themselves, or their whole family, in one place. This app also allows families to receive outbreak alert notifications for their area, and provides information on what vaccines are needed for protection. ### Immunization text messaging reminder cards

A new program that offers text message reminders to clients of upcoming scheduled immunization appointments is now available. This service can be used in a couple of different ways; it can remind parents to make an appointment for their child's immunizations, or to remind them of an appointment they already have. This service can be used for any immunization. There are also cards available at your local health unit that provide all of the information clients will need to sign up for this service. # Cervarix™ Vaccine One Time Program Still Available

B.C. is still offering the onetime program of publicly funded Human Papillomavirus (HPV) vaccination (Cervarix<sup>™</sup>) at no cost to women 26 years of age and younger, at the time of commencement, and born before 1994. This vaccine protects against 2 types of Human Papillomavirus (HPV) that cause most cervical cancers. This program does not have a specific end date, and will continue until supplies are depleted. Pharmacists authorized to administer immunizations have access to Cervarix<sup>™</sup>, and can administer it to eligible

B.C. residents. The vaccination program is supported by new online tools including www.dontgetcancer.ca. On this site clients can get text reminders for follow-up doses, find clinics close to them, and get access to different information about HPV. Clients can also receive text messaging reminders for this vaccine as they can for any other vaccines through the Immunize BC website. The partnership between public health and pharmacists allows the public more access to this vaccine as we strive to reduce rates of HPV.

# Northern Health Webpage for Community Vaccine Providers


