All samples must be accompanied by the requisitions issued to you. Please do not photocopy or re-use requisitions. If you need a new requisition, contact your EHO or nearest Health Unit office to obtain new forms.

**REQUISITIONS and SAMPLE BOTTLES** must have the date and time of sampling written on them by you.

CONTACT THE NEAREST NH OFFICE FOR SAMPLE BOTTLES AND REQUISITONS.

Outside NH, the nearest Health Unit office should be able to help you.
